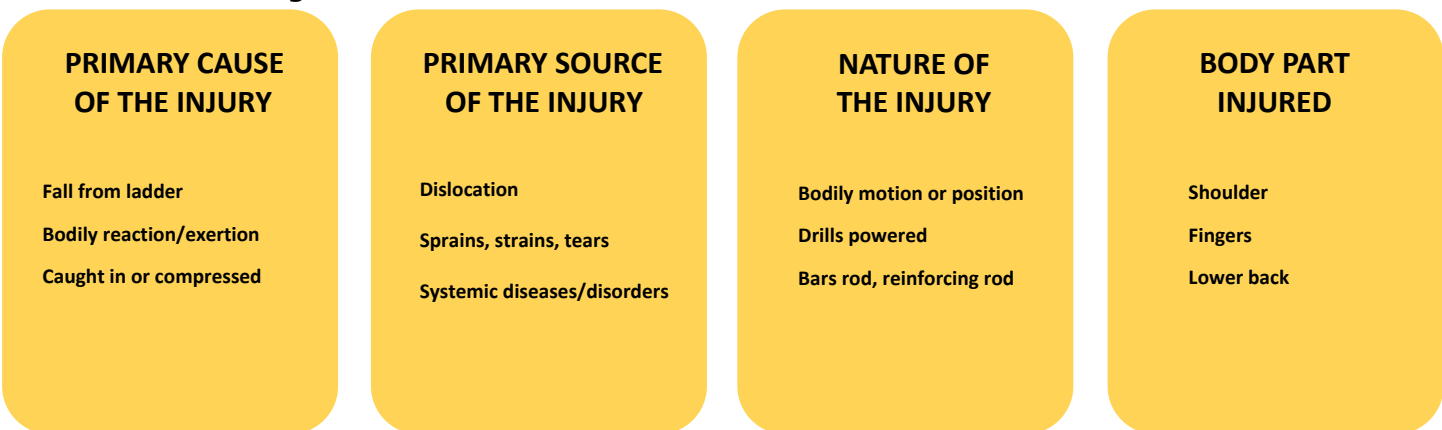
## TIMELOSS INJURIES

## 40104 INSTALLING METAL PRODUCTS

Installing Metal Products is one of the smaller Industry Classifications at under 1% of overall CSAM payroll. The Payroll in this classification has remained relatively flat over the past few years.

Currently, the Classification is slotted into the 300% Risk Category and approximately 58% of the payroll is safety certified.

Severe Injuries year over year remain relatively stable. In 2021, 4 Severe Injuries were incurred with 2 of these occurring in a safety certified work environment.

We refer you to the cover page to identify the top (3) drivers of Severe Injuries in the classification. Given that Severe Injuries amount to more than 80% of claims costs, they should continue to be the primary focus of any initiatives going forward.
