This classification is a non-levied classification showing a 2022 Actual Payroll increase of 13% or \$65.7M. Approximately 32% of the payroll is certified.

In 2022, the classification incurred (2) Severe Injuries and (16) Time Loss Injuries, both down from the previous year.

This classification was recently moved to the 33% Risk Category from the 25% Risk Category and is now showing claims costs more reflective of the 40% Risk Category.

Please refer to the cover page to view the accumulated data. Due to the low number of Severe Injuries over the past (5) years the data is reflective of Time Loss Injuries incurred over the same time frame.
