This classification was once the second largest levied classification primarily involving northern Hydro Projects. The payroll seems to have stabilized at \$43.9M of which 70% is safety certified.

Severe Injuries have dropped from 7 in 2023 to 3 in 2024. Claims Costs continue to drop as well as the classification is now tracking towards the lower risk category of 150%.
